



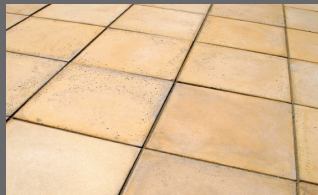
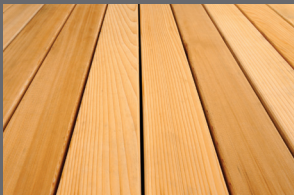

# Driveway, Decking & Patio Cleaner

Knockout® Outdoor Driveway, Decking & Patio Cleaner is ideal for cleaning concrete driveways / pathways, block paving, patios and decking areas. Contains a surface biocide to kill unsightly Mould, Fungi and Algae from decking, patios and other hard surfaces whilst cleaning general dirt and grime from the surface. Ready to use. Contains <5% cationic and nonionic surfactants.

## DIRECTIONS FOR USE

Remove all loose matter and visible growth from surface to be treated. Apply generously by spray, brush or cloth. Ideally leave up to 24 hours, then wash any excess treatment with clean water. It maybe necessary to repeat the process for heavily contaminated areas. Driveway, Decking and Patio Cleaner is not a bleach so will not remove all stains. If applying to exterior surfaces, do not apply if rain is imminent.

**Note: Test on an inconspicuous area first to ensure compatibility.**

## AFTER USE

Clean application equipment with water.

## APPLICATION RATE

One litre per five square metres.
